DISCUSSION	No updates.				
ACCREDITATION 1	ACCREDITATION TIMELINES				
DISCUSSION	 Timelines have changed to reflect change in follow-up to three years post-site review rather than two. Fall 2021 to Winter 2022: formal internal reviews will be conducted for programs with Notice, External Review, or APOR. Documentation will be required in spring 2021. Programs to be reviewed are Obstetrics/Gynecology, Psychiatry, Maternal Fetal Medicine, Anesthesia, Medical Oncology, Cardiology, Ophthalmology, Neuroradiology. Fall 2021 to Winter 2022: focused internal reviews will be conducted for programs that have had specific areas of improvement identified, these programs are: Neurosurgery, Clinical Pharmacology, Emergency Medicine, Plastic Surgery, Rheumatology, Electrophysiology. PGME will send a request for volunteers for Internal Review teams. Fall 2022: Royal College and CFPC on-site surveys will be conducted for programs with status of Notice and External Review. 				
CPSO LICENSURE					
DISCUSSION	 Questions have been raised regarding how trainees will find supervisors. Program Directors can be supervisors, but that isn't feasible for large programs. Hope is that residents will be able to locate their own supervisors, and that supervision will be minimal and can be done remotely. No formal, legal language has been forthcoming from the CPSO regarding supervision requirement for this license. 				
EXAMS UPDATE					
DISCUSSION	 RCPSC has waived requirement for oral exams for spring 2020 cohort. Oral exams will be required for all future cohorts. CFPC has waived the Simulated Oral Office (SOO) exam for spring 2020 cohort. The exam will be required for all future cohorts. When exams have been rescheduled, both Colleges will provide notice a minimum of 4 – 6 weeks in advance of the exam dates. 				
INTERNATIONAL T	RAINEES				
DISCUSSION	 Exemption to Canada's border closure remains in place for international citizens approved for, or who currently hold, a valid work permit. Issue remains not knowing when other countries will open borders, airports, or resume outgoing flights. Visa Application Centres outside of Canada, which process work permit applications, are closed, which may contribute to delayed arrival and start dates. Kuwait sent out notice that any medical trainees wanting to return home will be repatriated, but they are not required to return to Kuwait. Programs expecting international trainees to arrive for a July start are advised to be flexible with start date, and cautious about scheduling new international trainees in the month of July as arrival times are subject to change. 				

PGY1 RESIDENTS - JULY START The majority of Canadian International Medical Graduates (IMGs) coming to Western are already in Canada, or are arriving within the month. They will complete their selfisolation well in advance of July 1, so IMG start dates may not be impacted. PGY1 residents are expected to start on July 1st, but given the possibility of issues with onboarding new residents, including the possibility of mandatory two-week selfisolation after arrival in London, changes to completing mandatory training required **DISCUSSION** for hospital privileges, limitations to availability to complete health review with Occ Health, etc. programs are advised to be cautious with putting new PGY1s on call schedules during first two weeks of July. PGY1s will not have ACLS training prior to their start date, ACLS training will be required at some point in the future when available. PGY1s will be required to write MCC exam when it has been rescheduled. This means residents will need to be taken off call when they're required to write the exam or complete ACLS, we don't vet know when this will be. **CARMS UPDATE** CaRMS timelines will be changing but are not yet finalized. Information will be shared once the revised timelines have been finalized. Third year medical students are losing (at least) three months of clinical training, and opportunities for electives have been eliminated or decreased. This will have to be taken into account during their application cycle. PGME and UGME Deans hope to coordinate nationally and develop a set of principles, fair for both students and programs, to determine how to view elective opportunities during their CaRMS match **DISCUSSION** process. Interview process is likely to be a virtual format, including applicants from Western. This will impact how programs and how candidates can promote themselves, with the loss of site tours, gatherings etc. As CaRMS selection process approaches, programs will be called upon to pool best practices. Suggestion made to create promotional videos, host virtual chats with resident groups etc. Not yet known whether CaRMS changes will apply to subspecialty matches as well.

APPROVAL OF TE	RMS OF REFERENCE: PGME COMMITTEE & POLICY SUBCOMMITTEE
APPROVED	 Based on suggestions in the review report following the Institution Review, the terms of reference for the PGME Committee and Policy Subcommittee have been revised, with basis in the Institutional Standards. CBME UPDATE	
DISCUSSION EPA PLANNING CBD LAUNCH	• Per RCPSC webinar of April 9 th , launched programs are encouraged to communicate to residents that they can defer EPAs temporarily. If not an option, programs are encouraged to consider how EPA completion can be inferred, and stressed importance of documenting what the inference is based on (e.g. simulation, case discussion etc.). Programs unable to determine an alternative or that can't provide clinical opportunity are encouraged to contact the Royal College. Programs encouraged to continue to hold Competence Committee meetings.

- The twelve programs launching in July will receive a survey from the Royal College in mid-April, and are encouraged to provide feedback. After the Royal College reviews the survey results, a formal recommendation will be made regarding the 2020 launch.
- CBME team is continuing to work on development of Elentra EPA reports, EPA expiry report modified from 14 to 30 days. 2020 programs will be provided all forms for all stages built in Elentra in time for July 1st.

OBJECTIVES AND COMPETENCIES IN A COVID ENVIRONMENT

DISCUSSION

- In the current environment of disrupted training, programs are encouraged to pursue resources for offering virtual care. CFPC has provided tips and teaching/assessment points for learners providing virtual care; links to those documents are provided in the PGME information and updates package sent out April 14th.
- Programs are encouraged to ensure that residents experiencing disrupted training or a modified schedule cycle are delegated learning opportunities with accountability for some of that time; this could take the form of Reflections, Self-directed learning, Independent learning project, Case presentation and case study, Literature review, Exam question development, Exam review etc.
