Remarks commonly used during adjudication for BMSc students (and an interpretation) are below.

There are several comments to choose from to inform students that they are eligible for their ITR choices – the comments that you see depend on last year's program/plan (degree/module/faculty) and what you requested during ITR.

Remarks about Eligibility for Intent to Register Choice(s)	Interpretation
Eligible for requested Honors module(s)/program.	You're eligible for the First Choice you submitted during Intent to Register.
Eligible to advance in Honors module(s)/program.	You're eligible for the First Choice you submitted during Intent to Register.
May continue in current module(s)/program.	You're eligible to continue in exactly the same program/plan as last year (we don't usually assign this to students requesting honors degrees)
Not eligible for requested module(s)/program.	You're not eligible for your ITR choices. This comment is usually paired up with "degree and/or program changed ...". You'll see your program/plan for the upcoming year in Student Centre -- your program/plan has to be manually entered and it may take a few days or so until it is accurate.
Department decision-ineligible for requested Honors module(s)/program.	You're not eligible for the honors program you requested. This comment is usually paired up with "degree and/or program changed ...". You'll see your program/plan for the upcoming year in Student Centre -- your program/plan has to be manually entered and it may take a few days or so until it is accurate.
Not eligible to advance in Honors module(s)/program.	You're not eligible for the honors program you requested. This comment is usually paired up with "degree and/or program changed ...". You'll see your program/plan for the upcoming year in Student Centre -- your program/plan has to be manually entered and it may take a few days or so until it is accurate.
Eligible for BMSc degree with an alternative module(s).	You're eligible for the BMSc Program but the spaces in Honors Specialization module you requested filled up with students who had higher averages than your average. This comment is usually paired up with "degree and/or program changed ...". You'll see your program/plan for the upcoming year in Student Centre -- your program/plan has to be manually entered and it may take a few days or so until it is accurate.
Not eligible for BMSc degree. Eligible for B.Sc degree.	You're not eligible for the BMSc Program but you are eligible for a BSc degree. Your adjudication form goes to the Faculty of Science to finalize the remarks and program/plan for next year. This comment is usually paired up with either "not eligible for first choice ... eligible for second choice" or "degree and/or program changed ...". You'll see your program/plan for the upcoming year in Student Centre -- your program/plan may have to be manually entered and it may take a few days or so until it is accurate.
Not eligible for first choice Intent to Register requested module(s) or program. Eligible for second Intent to Register choice.	You're not eligible for your First Choice and you will be registered in the Second Choice that you submitted during ITR. See the ITR tab (Student Centre > Grades) to see what you submitted as your First and Second Choices.
Degree and/or module(s)/program changed per Faculty decision. Review registration for coming year in My Possibilities in Student Services.	We have to specify your program/plan for the upcoming year. You'll see your program/plan for the upcoming year in Student Centre -- your program/plan has to be manually entered and it may take a few days or so until it is accurate.

Remarks about Eligibility for Intent to Register Choice(s)	Interpretation
Registration in Double Undergraduate degrees approved.	You're eligible for the combined BMSc/HBA program.
May proceed in concurrent /combined program.	You were registered in the combined BMSc/HBA program last year and you're eligible to continue in it.
Eligible for Post-Degree module.	You're eligible for the Post-Degree module you requested. Only students who have graduated may pursue a Post-Degree module (Major or Minor).
Program is dependent on successful completion of summer course.	You are taking a summer course and, to maintain your eligibility for the program/plan in which you'll be registered next year, you must pass your summer course. If the summer course is either a required first-year course or a senior modular course, you will need to have a minimum mark of at least 60% in it. We'll get an another adjudication form after the final mark has been released to make sure you successfully completed the summer course and an updated set of Remarks will be posted to Student Centre.
Progression in program is dependent on successful completion of special condition.	If you're taking a summer course and need a mark higher than 60%, this will be specified as a comment on your academic record (see "How to view your special permissions and comments"). If you have an outstanding special examination or incomplete mark, this comment will be assigned to indicate that successful completion of the outstanding course is mandatory.
Must complete specific course condition per Faculty decision.	This comment is used with the comment above to specify the actual mark required in the specific course.
Registration changed to Faculty of Science, 3 year BA with an Undeclared Area of Concentration.	You're not eligible for either a BMSc or BSc degree and you will be registered as BA Undeclared for the upcoming year.
Not eligible for Scholar's Elective or Western Scholar. Eligible for Honors module(s).	Although you're not eligible for either the Scholar's Electives program or the Western Scholars designation for next year, you are eligible for the Honors degree with the modules you requested.
Not eligible for Honors Specialization. Eligible for four year non-honors Specialization.	You're not eligible for the Honors Specialization you requested and will be registered in a Specialization in the same subject for the upcoming year.
Not eligible for Honors Double Major. Eligible for non-Honors Double Major.	You're not eligible for an Honors degree with the two Majors you requested and you will be registered in a 4-year non-honors degree with the same two Majors (Double Major).
Eligible for Honors Specialization without additional Major module.	You're eligible for the Honors Specialization module you requested but not for the Minor you also requested. You'll see your program/plan for the upcoming year (Honors Specialization module, only) in Student Centre -- your program/plan has to be manually entered and it may take a few days or so until it is accurate.
Eligible for Honors Specialization without additional Minor module.	You're eligible for the Honors Specialization module you requested but not for the Major you also requested. You'll see your program/plan (Honors Specialization module, only) for the upcoming year in Student Centre -- your program/plan has to be manually entered and it may take a few days or so until it is accurate.

Remarks about Waiting List	Interpretation
On waiting list for requested program/module. Contact the Basic Medical Sciences Education Office immediately.	You've been put on the waiting list for the Honors Specialization of your First Choice. You don't need to contact the BMSUE Office as we should have paired this comment with "degree and/or program changed ...". You'll see your program/plan for the upcoming year in Student Centre -- your program/plan has to be manually entered and it may take a few days or so until it is accurate. You will be notified if a space becomes available for you in the Honors Specialization of your First Choice.
On waiting list for first choice. Registered in second choice.	You've been put on the waiting list for the Honors Specialization of your First Choice and you will be registered in your Second Choice. You will be notified if a space becomes available for you in the Honors Specialization of your First Choice.
Additional Remarks	Interpretation
Special Examination privilege(s).	This is just a comment -- your final mark wasn't available at adjudication time for a course in which you had been granted a special exam.
Must consult the Academic Counsellor(s) of your faculty with regard to module(s)/program and/or progression requirements.	You should contact a counsellor in the Dean's Office, Faculty of Science, about your progress at Western (scibmsac@uwo.ca)
Permission granted by Department(s).	Special permission has been granted by the department offering the module in which you'll be registered because you are technically not eligible to register in the module (e.g. a mark in a modular course may be lower than normally allowed or a modular course required for progression to the next year may not yet have been completed).
Conditional upon review of courses completed on Exchange or Letter of Permission.	You've been accepted into a module for the upcoming year, pending review of your transcript from the exchange or Letter of Permission university. Once the marks are posted on your academic record, we'll re-adjudicate you and an updated set of Remarks will be posted to Student Centre.
Students taking course(s) on a Letter of Permission must arrange for an Official Transcript(s) to be sent directly to the Academic Records-Registrar's Office at the University of Western Ontario.	This is a reminder that you must order an official transcript to be sent to Western's Office of the Registrar once the course(s) are completed. If a final transcript isn't received, you will receive a failing grade for the course (whether you took it or not).
Consult department prior to course selection.	You need to contact the department offering the module in which you'll be registered for next year as there is some concern about your course selection for the upcoming year.
Review registration for coming year in My Possibilities in Student Services	Check Student Centre to see what program/plan has been assigned to you for the upcoming year. Your program/plan likely had to be manually updated and it may take a few days or so before it is accurate.

Remarks about Required Courses	Interpretation
Next registration must include specific course(s). Contact your academic counsellor for specific details.	You need to take a course next year that usually would have been completed by students going into your module/year. Check the Academic Calendar for your modular requirements before contacting an academic counsellor.
Next registration must include mandatory module course requirement(s). Review degree and module requirements by consulting your Academic Calendar.	You need to take a course next year that usually would have been completed by students going into your module/year. Check the Academic Calendar for your modular requirements before contacting an academic counsellor.
Next registration must include year 1 Mathematics.	Check the Academic Calendar to see which first-year math courses are needed for your module and include the appropriate course in your selection next year.
Must upgrade mark in specific course by repeating it, to request entry into desired module in the future. Read Academic Calendar for specific admission requirements for desired module.	You need to either repeat or replace a particular course(s) in order to be considered for the module you requested. Check the Academic Calendar to determine which course(s) must be repeated and what minimum mark(s) is required.
Modules have common courses. Consult Academic Counsellor of faculty/school offering modules for policy on double-counting, and contact departments for substitution courses, if required.	You'll be registered in two modules next year and the same modular courses show up in both modules. Consult the policy on common courses and make sure you work out your course selection: http://www.uwo.ca/bmsc/courses.htm If you are registered in two modules with common courses for the upcoming year but you plan on completing a degree with only one module, you don't have to worry about the common course policy.
Must complete outstanding Year 1 prerequisite(s) for module(s)/program at next registration. Consult UWO academic calendar.	You need to include a first-year course (likely the physics requirement) in your selection next year as it is a mandatory requirement for your module.
Permission has been granted to register in requested module but next registration must include outstanding Year 1 prerequisite. Read Academic Calendar for specific admission requirements for module.	You need to include a first-year course (likely the physics requirement) in your selection next year as it is a mandatory requirement for your module.
Remarks about Graduation Requirements	Interpretation
Must complete first year requirements.	You haven't completed the first-year requirements needed to satisfy the graduation requirements. See http://www.westerncalendar.uwo.ca/2012/pg125.html
Must complete Essay course requirement.	You have to complete the essay requirement for graduation. See: http://www.westerncalendar.uwo.ca/2012/pg125.html
Ensure a total of 1.0 course from Category A as a breadth requirement is completed for graduation. Consult Academic Calendar for Category A details.	You have to complete the breadth requirement for graduation by finishing up the Category A requirement. Ensure a total of 1.0 course from Category B as a breadth requirement is completed for graduation. Consult Academic Calendar for Category B details. You must have 1.0 course at the first-year level (1000-level) from Category A or B. Science and BMSc will allow a half course from Category A and a half course from Category B to satisfy this requirement.
