National CBME Leads

The other university CBME Leads, or National CBME Leads, hold teleconferences every two months. Relevant info:

- Disciplines with subspecialties have to decide how any EPAs in the last stage of residency, Transition to Practice (TTP), could potentially be handled by the subspecialty the resident will enter.
 - o Psychiatry has determined this for the subspecialties in Child & Adolescent Psychiatry and Geriatric Psychiatry.
 - o Internal Medicine is still deciding with each of its subspecialties what models to adopt.
- Competence Committee members can include faculty who are on their discipline's Exam Committee as long as any conflicts of interest are declared prior to the resident review.
- The first three <u>Technical Guides on CBD</u> were released last fall. Topics for upcoming Technical Guides include Versioning and Credentialing guides (transfers into a CBD program, returning after a leave, and determining exam readiness). Along with a discipline's <u>CBD Specialty Standards Document Suite</u>, these technical guides are fundamental for your implementation.

Elentra login reminder

Residents and faculty members automatically have an Elentra account. Username and password are the same as your Western ID. If you have security questions set, you can reset your password here. 
Academic Advisor Set-up

PREVIEW of Elentra Dashboard for Competence Committee members!

The screenshot below shows a mock-up of our biggest development in progress, a functional dashboard in Elentra. The dashboard will take into account all of those contextual variables required for an EPA (e.g. x number of emergency cases, x number by a faculty assessor) and cohort comparisons that should make life much easier for Competence Committee members. A very similar dashboard will be created for residents. Both dashboards are expected to launch for July 1st, 2021.

Observing CC meetings for the 2019 programs


I continue to observe the CC meetings for programs who launched in 2019 since they have more than one year under their belt. It is incredibly valuable to see the group discussion and decision making in action as it helps inform the dashboard development in Elentra and bring to light challenges and questions that apply for everyone to the relevant stakeholders: PGME, our CBME Steering Committee, Clinical Chairs, and the Royal College.

Distributed Education

- Discussion is underway with **Dr. Larry Jacobs, Associate Dean of the Windsor campus**, for collaborative faculty development sessions with our colleagues in Windsor.
- In November 2020, a needs assessment was sent out to faculty in our <u>Distributed Education</u> network to engage them and see how we can help with their CBME questions. The needs covered the typical topics of Elentra, the basics of CBD, and some more specialty-specific questions about expectations of EPAs.

Program Evaluation

From Andrea Good, Program Evaluation and Project Coordinator (CQI & Accreditation), PGME



The PGME Office has begun providing EPA assessment expiry reports to programs that use Elentra in order to build on, and support, the information provided through Elentra's faculty assessor reports portal. The goal of the EPA expiry reports is to provide CBD programs with evaluation information on their EPA completion, expiry, and deletion information in order to better understand their successes and areas for improvement. These reports also provide an anonymized comparison to all other programs, and to programs in similar specialists ("nests"), where applicable.

The first EPA expiry report was sent to all CBD Program Directors who use the Elentra platform in December 2020. The reports will be sent quarterly, based on the following periods:

- July-September
- October-December
- January-March
- April-June

The next report will be sent in mid-April but will report on EPAs from December 2020 – March 2021. Provide feedback on the report template, format, and information included to Andrea (andrea.good@schulich.uwo.ca). We also encourage Program Directors to regularly review Faculty Assessor Statistics in Elentra for accountability purposes.

Steering Committee

This committed group of PDs, CBME Leads, and representatives from the PA Exec, RAC-CBME, CERI, and Schulich IS developers have discussed the more challenging issues of

- Accessing Elentra on hospital computer, the mobile experience of Elentra;
- Dashboard creation and prioritization of components needed;
- Determining what exactly constitutes the various resident status recommendations for a program, e.g. what determines 'not progressing as expected' vs. 'failure to progress';
- Reporting to PGME certain <u>CC resident status recommendations</u>;
- Weighing pros/cons of residents completing portions of the EPA forms.

Resident Advisory Committee for CBME (RAC-CBME)

Resident Feedback Survey

In December, a feedback survey for residents at Western was circulated that covered many areas of CBME. The report of the summary findings are included and we will continue to dissect through each section at upcoming stakeholder meetings. In summary, at a bare minimum, faculty must

- learn their Elentra login
- set a PIN
- ensure they receive email notifications

We also highly recommend that faculty broach the topic of EPAs with their learners as it can be intimidating for learners to ask and not want to "bother" faculty. We must all do our parts to relieve the burden it has placed on residents.

RAC-CBME Meeting notes from resident-only portion

At the end of each RAC-CBME meeting, the residents meet without any members from PGME to talk freely about any issues. A summary note of the discussion is provided. Two points from the February 2021 summary note that are relevant are below. Please consider if this applies to your program and we urge flexibility for these requirements which includes making the change going forward, but not *retrospectively* changing requirements; or, please communicate with your residents if this was a misunderstanding.

- "Program Directors are sending conflicting messages on EPA requirements.
 - O In previous years some options were not available to residents (e.g., allied health filling out EPA's) and we were told to ignore that requirement, however, it is now being brought back up that the resident missed this EPA and are in trouble for not getting it.
 - O Fellows previously counted as staff as you work one-on-one with fellows in certain clinical scenarios. In Oct/Nov fellows no longer counted as staff. This change was not communicated to residents and now residents are deficient in certain EPAs. Can fellows be changed back to staff?"

PA Resource for CBME

Course Info

This novel competency-based course is designed to provide new and aspiring program directors with skills and tools to both manage an existing curriculum and system of assessment, and to develop a new curriculum and system of assessment. The course includes:

- A step-wise approach for designing education, including conducting needs assessments, writing learning objectives and choosing appropriate instructional strategies and assessment methods.
- Best practices for curriculum design and curriculum mapping.
- Planning and implementing CBME in your context, including the use of competency frameworks (e.g., CanMEDS).
- Applying the eight core ingredients in building an effective system of assessment, including how to incorporate workplace-based assessment, coaching and feedback, as well as guidelines for collection of both numeric and narrative ratings of performance.

Timeline

The 10-week pilot will begin in Spring 2021. 25 enthusiastic program directors will take the course and give crucial feedback on both its structure and content.

Participant Commitment

Participants can expect to spend 1-2 hours a week over the 10 weeks program completing 4 modules asynchronously, culminating in three synchronous virtual workshops during the latter half of the program.
