


Chart 1: Outlines the status of program meetings. Green programs represent those that have had a meeting. Out of the 18 programs that have had a meeting, six included the department/division chair chief which was beneficial in getting them engaged in faculty accountability efforts. Two programs have not yet responded. Eight programs are doing well and do not require a meeting. Five programs are holding off until they either have a CBD learner or there is a new PD in place.

- The resident feedback survey is now closed.
  - The report has since been finalized and can be accessed <a href="here">here</a>.
  - The last RAC-CBME meeting of the academic year was on May 2<sup>nd</sup>. Dr. J. Vergel de Dios thanked Dr. A. Zaki and Dr. S. Hinton for their contribution and advocacy over the past year. Dr. M. Nuaaman and Dr. L. Calderon, both Internal Medicine residents, are the new incoming resident co-chairs.

**ACTION ITEMS** 

• Committee to read the resident feedback survey results.

- The current focus is on preparing Elentra for the incoming 2022 programs: Maternal-Fetal Medicine, Neuropathology, Diagnostic Radiology, and Hematology. Anesthesiology is moving into Elentra from ePortfolio and Medical Oncology has changes to their EPAs.
   P. Morris is working through day-to-day support requests.
   P. Morris and C. Koerber are working to enhance feature flyers and the user guide to promote users to be as self-sufficient as possible.
  - The IS team has made significant enhancements to the Elentra servers which has reduced load times significantly. If you are still experiencing issues, please reach out and let us know.
  - External assessor management:
    - P. Morris is working on identifying and blending faculty that have been added as external assessors in error and are missing from the assessor statistics report. P. Morris is also working on cleaning up actual external assessors that have been added multiple times by residents to ensure they only appear once. IS is working on a strategy to validate external users on a regular basis so that duplicate records are avoided entirely.
  - P. Morris is working on a list of future enhancements, this will be presented to the SC in the fall for prioritization to be submitted to IS for the upcoming academic year.
  - Dr. A. Florendo-Cumbermack noted that her program houses forms in One45 and Qualtrics and asked if there is a way for the program to create forms themselves in Elentra as the CC is having to look across various platforms. P. Morris explained that this is the plan for non-EPA assessments, however the IS team must first ensure that the Elentra customization is set up properly first. In the future, programs will be asked to maintain all of their own non-EPA forms in Elentra. The plan is to begin moving forms over in the next academic year.
  - It was asked whether PDs and CBME Leads can be given the ability to manage program contacts in Elentra, a function that currently only PAs have access to. P. Morris will speak with IS to determine if this can be changed.
  - Dr. H. Iyer asked whether the goal is to transition AFC programs into Elentra as well. P. Morris
    explained that all programs will eventually move into Elentra, however our priority right now is on
    official CBD launches, taking us through to 2024.
  - Committee to reach out if they are still experiencing speed issues in Elentra.
  - P. Morris to speak with IS about giving PDs and CBME Leads access to manage program contacts.

## 4. ASSESSMENT BURDEN RESEARCH – DR. MARY OTT

- Dr. Mary Ott presented at the ICRE conference on understanding assessment burden for residents in CBME.
- Essential questions to take away include: How does stress emerge in the CBD system? What can be done to support resident well-being? What is your agency to improve the experience of CBD?
- Resident assessment burden is an unintended consequence of CBD. Broadly speaking, resident stress includes the burden of responsibility in seeking out EPAs and the low value residents perceive of the feedback compared to this workload.
- 21 residents across Canada (half were Schulich residents) were interviewed on their CBD experience.
- The research surrounds self-determination theory which stipulates that competency, autonomy, and relatedness are fundamental and interdependent psychological needs. When these needs are met in a system, performance and well being improve. However, in their absence, performance decreases and stress increases.
- The research found 9 different types of assessment burden, and a missing need in one area negatively affects other areas (compounding burden).
- For example, one resident said when speaking on knowing what CVs are missing on an EPA to
  get an achieved status, "It is hard to know which one you are missing, there are a bunch of
  different subcategories." This stress point is a lack of clarity due to a disconnect in the teachinglearning situation. The lack of clarity becomes a compounding stressor and causes a second
  stress point of a missed opportunity to self-regulate learning.
  - What is being done to overcome this? Academic advisors; timely response to questions
- Another stressor is a lack of situational control (i.e., being held accountable for something that you have no situational control over). This is compounded when there are unrealistic expectations.
  - o What is being done to overcome this? Use of simulation sessions
  - In summary, there is a triple threat to learning and well-being. A burden in one area has negative implications in other areas.

	<ul> <li>What can be done to help learners thrive as originally intended under CBD?</li> <li>We need to implement learning conditions that support intrinsic motivation, well-being, and high-quality learning. These factors are interdependent.</li> <li>Dr. Mary Ott explained the difference between formative vs. normative assessments. Formative assessments are in-the-moment and outlines that needs to be improved upon. Normative assessments are summative check-ins that do not outline what needs to be</li> </ul>

Once the hospitals stop using Internet Explorer, we can look into this option further.</li> <li>The note below is from the LHSC E-cast newsletter from June 9, 2022:         <ul> <li>Microsoft is retiring Internet Explorer, one of the oldest web browsers that was first launched in 1995. Modern browsers, like Microsoft Edge and Mozilla Firefox, will replace Internet Explorer by providing increased security and much improved user functionality. If you open Internet Explorer after July 5 on a hospital computer, or the Horizon Corporate Desktop, you will be automatically redirected to Edge. If you still use Internet Explorer on a work computer, you will have until June 15 to move your favourites into Edge, or they will be permanently deleted.
