Clinical students (Dents 2024 and 2025) must have completed their appointment with Synergy Verified and obtained a status of **PASS** by **July 28, 2023**

Please note that <u>all documentation meeting the Dents 1- Entering Student Requirements must be uploaded</u> to your Verified account AND students must have received a notation of "PASS" on their previous year's <u>appointment with Synergy</u>. To determine this, students must login to their account in Synergy Gateway's Verified system and check what has been written for them under the Communications tab. If documentation is missing or follow up is required, you will see a notation. Please ensure you have all required documentation uploaded before your scheduled appointment to avoid extra charges.
