3.0 UPDATES

3.1 PARO UPDATE - S. SCOTT

- Resident Appreciation Week was February 5 to 9; several events held to celebrate residents including a catered lunch at the Chatham site, free coffee and a board game night at SAGA Board Games & Coffee, and an arcade night at Rec Room.
- Skating social in March at Storybook Gardens.
- Continuing to work on the non-urgent paging project and improving the EMR.
- L. Champion thanked residents for all they do and recognized residents as the backbone of the system.

3.2 PATIENT SAFETY REPORT - S. PAGURA, LHSC

- We have an incident reporting system to understand where system failures are; without this information it difficult to make it better for patients, staff and caregivers; goal is to reduce future harm and quality improvement.
- When an incident is submitted through AEMS, process, systems and structure are reviewed, does not look at clinical performance; a triage call occurs to see if definition of critical incident is met; executive leaders determine if incident requires Quality of Care Reflective Review (Root Cause Analysis); this process must be completed within 4 weeks, families are involved; recommendations are provided, information shared with Quality of Care Review Committee, Medical Advisory Committee and the Quality and Culture Committee of the Board; consistent follow-up is done.
- LHSC has seen 20,000 incidents over the past 3 years, likely only 10% of what is actually happening; top four incidents at LHSC: falls, medication, treatment, laboratory; falls and treatment incidents are both the highest cost (hospital or legal) and highest risk of mortality.
- Patient rooms, treatment areas, bathrooms and hallways the locations where most incidents happen at both LHSC hospitals.
- LHSC has completed 76 Quality Care Reflective Reviews and made 375 total recommendations; 23 recommendations were geared towards learners.
- Action Item: PDs requesting more clarity on what a PDs role is when not involved in incident but one of their residents is; S. Pagura to take back to team and work on providing resources.
- LHSC transiting to new reporting system; new system will be shown at a future PGME Committee meeting.

3.3 PGME EDUCATION UPDATE - S. MACGREGOR

- Update on Current Education Programs:
 - Resident as Teacher Bootcamp (RTBC) 2024
 - Held this past Thursday and Friday; very positive feedback; compiling resources to share with attendees
 - Certificate in Leadership (CiL)
 - February 15 Teamwork
 - April 11 Leadership
 - Serious Illness Conversations Retreat (SICR) 2024: March 1 at Ivey Spencer.
- Orientation 2024 process has started; Western has switched to a new learning management system (OWL Brightspace); working on migrating material from OWL.

3.4 ELENTRA UPDATE - P. MORRIS

- 2024 CBD Program Launches: Infectious Diseases and Gynecologic Reproductive Endocrinology & Infertility; 8 programs with EPA revisions for July
- Off-boarding from one45 to Elentra has been pushed to July 2025 due to lack of resources within PGME, need to ensure successful migration.
 - o A communication about this delay will be sent out to all PAs.

3.5 CARMS UPDATE - L. CHAMPION

- CaRMS provides an option in program description to indicate if program uses information outside of the application information provided in the portal; this could include social media and unsolicited information such as reference letters, email information and verbal information from colleagues and coworkers.
- Concerns regarding social media as well as unsolicited information and validity/accuracy. Using this information could become problematic and could lead to complaints.
- For future matches, suggest that programs not count or be influenced by unsolicited information; PGME's Selection Policy will be revised with suggestion that those involved in file review or interview be recused for applicants they have written a letter of reference for; Conflict of Interest and Confidentiality Agreement templates are available and should be used by selection committees.
