#### 3.3 CaRMS MATCH

• All PGY1 positions have been filled after the second iteration

- Total of 192 positions
- 78 for Family Medicine
- Blending of second iteration resulted in increased number of International Medical Graduates in Family Medicine

#### 3.4 MOH UPDATE- MEDICAL EDUCATION EXPANSION

- 2023 match increase in 10 PGY1 positions
- Allocated 9 to PGY1 (and 1 to FM-ES)
- 2 Family Medicine
- 1 Internal Medicine
- 3 Psychiatry (2- London, 1- Windsor)
- 1- Emergency Medicine
- 1- Physical Medicine and Rehabilitation
- 1- Anesthesia
- 1- Family Medicine Enhanced Skills
- 2024 Match additional 10 on top of what we had for 2023 and an additional 5 identified by MOH
- MOH target is 60% Family Medicine with understanding that there may not be capacity in FM programs in Ontario, in particular without additional resources and as PG positions increase without an increase in UG applicants there is a risk of unfilled positions (FM may be the most vulnerable program for unfilled positions in Ontario).
- Priority programs Anesthesia, EM, Psychiatry
- There will be a Resident Allocation Committee meeting for June to provide a tentative plan
- Tentative plan is:
  - -Additional 8 for FM
  - -Psychiatry and Anesthesia will have capacity for increase
- K. Chan feels that there is a shortage in general of Anatomical Pathologists coming down the pipeline.
- No additional funding for the expansion (funding as per usual resident funding)

## 4.0 NEW BUSINESS L. CHAMPION

#### 4.1 SAFE RIDE HOME

- We want to make sure this information is provided during orientation

#### 4.2 ACCOMMODATIONS - ROYAL COLLEGE

- Resident and fellow newsletter provided information about the new accommodation guideline and link
- Also provided information about Royal College requirements which will be provided unless they affect the validity of the examination – documentation may be required, and may include a psychoeducational assessment with outlined functional limitations if additional examination time is required (must be less than two years old).
- There is a reminder for exam registration etc.

#### Follow-up: Phone call Policy:

- Drafted, and provided to a number of Program Directors for initial feedback
- Will provide the next version to Clinical Chairs
   Will exclude situations where virtual care is part of a scheduled clinic (such as Family Medicine). L. Champion is working on version 4.

## 5.0 FOR APPROVAL: POLICIES

#### L. CHAMPION

#### 5.1 DRAFT STANDARDS OF ACCREDITATION FOR INSTITUTIONS

- You will be receiving an email for a survey from the Royal College asking for feedback
- These are the Standards of Accreditation that PGME must meet
- Some standards will be met by Schulich, and some by Learner Experience
- Examples for PGME that we have been working on:
- 1.2.1.4 regular review of PD performance with multiple sources of feedback
   → survey
- 2.1.1 Effective policies and process → well-defined, functional policies, regularly reviewed
- 8.2.1.4 common AFIs across residency programs → templates for TofR, agendas, CC resources, resident resources, PGY1 modules, hidden curriculum, etc.
- This is the second version a number of draft standards were removed based on PGME (Associate Dean) feedback
- Examples removed included standards that were out of scope of PGME or not feasible for example:
  - QI process includes regular review of patient data including experiences of racism and discrimination. (recognition that PGME will not have access to patient data)
  - Disaggregated race-based resident data regarding recruitment, remediation, probation, outcomes of appeals, transfers and dismissal rates are made publicly available and shared directly with Black and Indigenous communities in an accessible format. (recognition that this may compromise confidentiality, and may not be feasible)
- The Royal College is asking for feedback via a survey
- L. Champion will provide the link and ask that you complete it it is asking to: continue with the draft standard, continue with the modification, or remove it.
- List of the new standards
  - Institution Statement of Mission not within PGME control
  - PGME feedback concern that not including the term 'discrimination'
    meant that there could be a perception that the standards were not
    recognizing vulnerable learners at risk of discrimination for reasons
    other than race

#### DISCUSSION

- Language of 'anti-Black, anti-Indigenous racism and racism in all its forms...' could be perceived as less inclusive of other racial groups
- Islamophobia is not necessarily encapsulated by anti-racism
- K. Chan suggested to look at the standards together so that the changes are made consistently and made across all organizations
- A. Dukelow and S. Northcott feel that there is a lot of work to do and it needs to be a collective initiative
- S. Bains met with the people who are working on changing these standards on a national level and she thinks that our guidelines need to align with the rest of the country, not just our region
