1. CaRMS MATCH DAY Dr. Watling

2. CBME PROGRE	SS REPORT/COMPETENCE COMMITTEES Drs. Watling & Venance	
Discussion	. Mobile technology for e-portfolios will be available; the timeframe on when this will be available is not known . The Assessment and Appeals policy continues to be reviewed and revised; ITERS will be changed to one of a number of types of summative assessments that a program could use, freeing programs to develop assessment plans that may be better suited to the programs' needs . The RCPSC and Faculty Lead Group have been working on a readiness checklist that covers programs, school, and RCPSC; this new version is more practical and aimed at giving each program a timeline for when certain actions need to be put in place . The spring retreat will take place on April 21 st , 2017 and will be centered around competence committees . The Dean has affirmed that the school is intending on moving forward with a CBME plan for curricula across the spectrum from undergrad through all the postgrad programs, including CPD and faculty development . Program Directors can serve as useful champions in continuing discussions around CBME integration, especially with distributed sites	





2. TRANSITION TO PRACTICE J. Binnendyk			
Discussion	. PGME Academic Half Days discontinued and instead efforts focused on a transition to practice program that is a parallel to the transition to residency program . Practice management has been identified as an unmet need in the literature . Focus groups held to refine a survey instrument used to assess respondents' knowledge and experience around practice management . Highest gap scores included: contract negotiation; setting up practice; financial planning; medico-legal; and billing (respondents believe this topic should be taught at the program level) . Eight topics have been narrowed down and they include: Taxation/incorporation; financial planning/insurance; negligence/record keeping/privacy; CPSO, hospital privileges, consent & capacity; Physician wellness; setting up practice; negotiations; and quality improvement . Industry professionals interviewed using formal selection criteria to determine industry experience and expertise but also their facilitation skills . Piloted one topic on February 8th (Accounting Principles & Insurance); next pilot topic on March 8th, 1-4pm (Legal Considerations for Entering Practice) . Discussion continued on best timing for this series and possible funding options including holding the series on a Friday, Saturday, Sunday to increase resident availability and including recent grads and charging a fee		
3. MEDICAL ASSISTANCE IN DYING (MAID) R. Sibbald			
Discussion	. Mr. Sibbald Chairs a group that facilitates and maintains a list of provider physicians willing to assess for eligibility of medical assistance in dying and over the last six months, 51 referrals have been reviewed . Across Ontario there has been one completed case of assisted dying every day for the past six months . Residents have been involved in sending referrals regarding MAiD but the hospital policy is that residents can't be conducting the assessment or solely responsible for the procedure; residents have been involved in the room observing an assessment but not a procedure . When residents are first approached regarding MAiD, residents should be asking about the motivation for the request to the extent they are comfortable; the MRP must be made aware of the request . Residents believe they are not taught enough about end of life care . For more information, Mr. Sibbald will be presenting at Grand Rounds in Medicine on March 9 th at University Hospital in Auditorium B at noon; case stories will be shared		
4. TRUTH & RECO	NCILIATION COMMISSION Dr. C. Watling		
Discussion	. The Truth & Reconciliation Commission made several recommendations for the country and all levels of governments and education institutions . Two recommendations that touch medical schools:		





#23 i) Increase the number of Aboriginal professionals working in the health-care field; ii) Ensure the retention of Aboriginal health-care providers in Aboriginal communities; iii) Provide cultural competency training for all health-care professionals

#24) We call upon medical nursing schools in Canada to require all students to take a course dealing with Aboriginal health issues, including the history and legacy of residential schools, the United Nations Declaration on the Rights of Indigenous Peoples, Treaties and Aboriginal rights, and Indigenous teachings and practices.
