1. CBME PROGRE	SS REPORT Dr. Watling
Discussion	. Central supports within PGME have been put into place to assist all programs and Program Directors in work related to CBME . Sylvia Mioduszewski is the new CBME Education Technology Support Specialist and will be reaching out to each program but PDs are more than welcome to contact Sylvia when help is required . Joan Binnendyk is the new as CBME Curriculum Specialist. She will help map out within your program what the curriculum will look like and the sequence of learning experiences to help meet the outcomes required, and how to strategically place the right assessments in the right spots to achieve the outcomes you need . November 3 rd is the next CBME retreat with a focus on the practicalities of implementation . In November 2017 there is a national meeting of Postgrad Deans with the RCPSC and there will be a review of the nine programs intended to move to CBME on July 1 st , 2018 with a decision about whether they are ready to go ahead . While faculty in a CBME implemented program are all registered with the e-portfolio, supervisors on off-service rotations are not which creates a challenge for off-service rotations for CBME residents Programs have had to create work arounds for CBME style assessments to be done by faculty who are not signed onto the e-portfolio. The intention over the next couple of months is to have all faculty credentialed to access the e-portfolio . PGME encouraging RCPSC to credential individuals who are not already fellows of the RCPSC . PGME working on creating a list of faculty and those targeted to assess residents including senior residents and allied health professions to have access to e-portfolio

- . Dr. Lam shared Internal Medicine's Competence Committee (CC) membership and explained how having a subspecialty PD as a member, was viewed as a conflict of interest by residents
- . The Committee discussed who may have a conflict of interest when sitting on a CC
- . Programs will have to adapt and tailor CC membership based on the Program's specific situation
- . It was suggested to use faculty from outside the program who do not have a stake in that program's residents but can bring some perspective around fairness and procedural consistency
- . Resident representation on the CC was highlighted as a useful contributor

5. MCCQE PART II DATES

- . Over the last five years, there has been a 7-15% failure rate on the MCCQE Part II
- . Many residents don't disclose they've failed the exam to their PD
- . Every resident must complete this exam in order to become licensed which they can take at the end of their first year of residency

. PDs encouraged to think of ways to support residents and create an open door policy to have residents come and share their results

. The Committee will debrief once the results from the fall exam are available
