PREAMBLE

The Curriculum Committee (CC) is the primary governance committee of the Doctor of Medicine Program (hereafter MD Program) that is tasked by the Schulich School of Medicine & Dentistry (School) with the oversight and responsibility for the vision, design, management, integration, evaluation and quality improvement of the MD Program. The Curriculum Committee ensures the MD Program meets the requirements of the Committee on Accreditation of Canadian Medical Schools Standards and Elements and the Western University Institutional Quality Assurance Process.

The Curriculum Committee is also tasked with aligning the curriculum and MD Program processes with the:

- School's strategic priorities
- Principles of equity, diversity, inclusion, and decolonization in all curricular matters

The Curriculum Committee Reports to the Executive Committee of Schulich Council (ECSC), a delegated committee of the Schulich Council.

MEETINGS

The CC will meet 10 times per year over the academic year. The agenda and any supporting materials will be circulated to CC members one week before scheduled meetings. Minutes will be circulated one week following the meeting.

QUORUM

- Quorum (academic year) shall be 50% of the voting members of the committee.
- Summer quorum will be one-third of voting membership

RESPONSIBILITIES

CACMS Accreditation Standard & Elements Standard 8 Curricular Management, Evaluation, and Enhancement

The faculty of a medical school engage in curricular revision and program evaluation activities to ensure that the medical education program quality is maintained and enhanced and that medical students achieve all medical education program objectives and participate in required clinical experiences and settings.

• 8.1 Curricular Management

The faculty of a medical school entrust authority and responsibility for the medical education program to a duly constituted faculty body, commonly called a curriculum committee. This committee and its subcommittees, or other structures that achieve the same functionality,





oversee the curriculum as a whole and have responsibility for the overall design, management, integration, evaluation, and enhancement of a coherent and coordinated medical curriculum.

8.2 Use of Program and Learning Objectives

The faculty of a medical school, through the curriculum committee, ensure that the formally adopted medical education program objectives are used to guide the selection of curriculum content, and to review and revise the curriculum. The learning objectives of each required learning experience are linked to the medical education program objectives.

8.3 Curricular Design, Review, Revision/Content Monitoring

The faculty of a medical school are responsible for the detailed development, design, and implementation of all components of the medical education program, including the medical education program objectives, the learning objectives for each required learning experience, and instructional and assessment methods appropriate for the achievement of those objectives.

The curriculum committee oversees content and content sequencing, ongoing review and updating of content, and evaluation of required learning experiences, and teacher quality.

The medical education program objectives, learning objectives, content, and instructional and assessment methods are subject to ongoing monitoring, review, and revision by the curriculum committee.
