#### 4. Course Description and Design

**Delivery Mode:** in-person

Pharm 4360B is a half course to introduce students to the basic and advanced concepts in cancer biology and therapeutic properties of some anticancer agents. Recent advances in our understanding of the molecular and genetic basis of cancer as well as how signaling is altered in cancer cells are discussed, as well as how these alterations have led to modern targeted cancer therapies.

Prerequisite(s): Pharmacology 3620, or Physiology 3140, or permission from the Department.

- Design experiments to test hypotheses related to carcinogenesis.

#### Information about late or missed assessments:

- An assessment cannot be submitted after it has been returned to the class; the weight will be transferred to the final grade
- With approved academic consideration, the weight of a missed test or missed assignment will be transferred to the final exam

**INC (Incomplete Standing):** If a student has been approved by the Academic Advising Office (in consultation with the instructor/department) to complete term work at a later date, an INC will be assigned.
