

APPLICATION FORM - HIGHLY QUALIFIED PERSONNEL (HQP):

Pragmatic clinical trials are often embedded in routine care and involve the analysis of routinely collected data (e.g., health registries, electronic medical records, and administrative data). Done well, pragmatic trials yield valid generalizable results faster than explanatory ("traditional") clinical trials and can be completed at a fraction of the cost.

The <u>HDRN Canada Pragmatic Trials Training Program</u> is a <u>Clinical Trials Training Platform</u> funded by the <u>Canadian Institutes of Health Research</u> (CIHR). Coordinated by the <u>Schulich School of Medicine & Dentistry at Western University</u> and embedded within <u>HDRN Canada</u>, this two-year virtual pan-Canadian program will provide training to advanced learners across three streams: (1) future trial leaders, (2) postdoctoral fellows, and (3) highly qualified personnel.

Eligibility: Highly qualified personnel (HQP) must be employed at a public sector (e.g., academic institution, government, health care organization, research centre) or private sector organization (e.g., contract research organization, pharmaceutical or biotechnology company) in Canada. The HQP must be employed by an organization that desires to develop their capacity related to pragmatic trials research and the employer must approve, in writing, of the applicant's involvement in the training program.

Application deadline: Applications will be accepted until Friday, December 22, 2023 (5:00 PM Eastern time). Results will be announced via e-mail in February 2024.

Program duration: April 15, 2024 – March 31, 2026 (2 years).

Description: Acknowledging that HQP are advanced learners with various obligations, this training program is entirely virtual and largely asynchronous in nature. At minimum, HQP must be able to engage with tasks related to the program on a bi-weekly basis (6 hours over a two-week period, ~3 hours per week).

With the goal of creating a community of learners, attendance at monthly, one-hour virtual meetings will be required as well as routine asynchronous engagement (e.g., reflections on educational content) within a learning management system.

Public sector HQP employed by <u>HDRN Canada member organizations</u> will be involved, when possible, in an experiential project-based learning experience. The project should further HDRN Canada's ability to support pragmatic trials research (e.g., reducing barriers for analyses of routinely collected data, particularly multi-regional data, that informs trial design and execution). Throughout the program, HDRN Canada HQP will reflect and present on obstacles and solutions encountered during their projects.

There will not be an expectation for public sector HQP outside of HDRN Canada or private sector HQP to engage in project-based learning. However, such opportunities can be discussed after acceptance into the program on a case-by-case basis.

Funding: To facilitate the involvement of public sector HQP, public sector organizations will receive 150 hours of time release funding, per year, valued at a minimum of \$50 per hour (i.e., each public sector employer will receive a minimum of \$7,500 per year for each of their HQP in



the program). This amount may be adjusted based on the number of successful public sector HQP applications. Funding will be transferred to the public sector employer for a second year upon their HQP meeting year-one requirements. Private sector organizations will not receive any funding during the involvement of their HQP in the program.

Program offerings:

- Participants will have access to a learning management system with educational
 materials focused on pragmatic clinical trials (e.g., trials examining interventions that can
 be evaluated in routine care settings, with large diverse samples of patients, which
 produce generalizable evidence that informs real-world decision making).
- As a first time offering, the program will seek routine feedback from participants and adapt to help meet their learning objectives. Acknowledging the various obligations of participants, this largely asynchronous virtual program will facilitate experiential projectbased learning opportunities and foster the development of a vibrant community of learners.
- Participants will have access to a pan-Canadian network of <u>HDRN Canada member</u> organizations that have committed to providing further training and career advancement opportunities.
- Participants will have access to the <u>Wabishki Bizhiko Skaanj Learning Pathway</u>, and other related training, to enhance their knowledge and awareness of racial biases, Indigenous voices and stories, the impact of colonization on Indigenous health, and culturally safe health research practices.

Intended outcomes: At the conclusion of this two-year virtual training program, all HQP will have expanded their understanding of pragmatic trials and strengthened their networks through engagement with future trial leaders, postdoctoral fellows, and other HQP in the training program. This will allow HQP to serve as ambassadors for pragmatic trials within their host organizations. HQP employed by HDRN Canada member organizations may have contributed to an experiential project-based learning experience. A certificate will be provided upon successful completion of the program.

Applicant evaluation criteria: With the goal of training HQP who are committed to serving as ambassadors for pragmatic trials within their host organizations, a pan-Canadian selection committee will assess the following: the applicants (1) research training and experience, (2) need for specific training in pragmatic trials, (3) role at their employer and its relevance to pragmatic trials research, and the employers (4) overall mandate and mission, and its commitment to their HQPs involvement in the program.

The letter must describe the supervisor's experience with the applicant. It should reflect
an understanding of the pragmatic trials training program so that the supervisor and their
host organization can support the involvement of the HQP in the program over a twoyear period.

- Public sector organizations employing HQP: It must be understood that the time release funding may not match the hourly wage of the applicant. While the specified amount may be adjusted based on the number of successful public sector HQP applications, the employer should consider the feasibility of their HQPs involvement with the minimum funding allocation in mind.
- Private sector organizations employing HQP: It must be understood that your organization will not receive any time release funding for the involvement of your HQP in the program.
- In all cases, the supervisor should directly indicate in the letter that they will ensure their HQP has protected time to be involved in the program. If necessary, additional approvals from the employer's leadership can be sought and kept on file by the supervisor (for future reference, if ever needed).
- HQP from HDRN Canada member organizations: The letter should reflect that the
 HDRN Canada supervisor and applicant have collaboratively drafted the submitted
 project description to facilitate experiential learning. In the case where the applicant was
 not able to propose a project, an explanation (e.g., "My member organization does not
 have the capacity to support pragmatic trials research at this time") can be provided in
 this letter.
